

# SOMERS TOWN WALKABOUT 2

## TRA represented Estates

### **Goldington Street Estate**

- Mix of private and council accommodation, one block sheltered housing
- Cecil Rhodes House and Chenies represented by Goldington Street Estate Tenants and Residents Association

### **Unity Mews, Chalton Street**

- Origin Housing

### **St Nicholas Flats, Werrington Street**

- Origin Housing

### **Sydney Street Estate, Werrington Street**

- Origin Housing
- Student hostel accommodation above housing

### **Godwin and Crowndale Estates**

- Mainly Camden Council housing
- Represented by Godwin & Crowndale T M C
- Large sports area fenced off from outside

### **St Augustines House, Eversholt Estate, Eversholt Street**

- Security intercom with fob key, except for ground floor and only protecting internal access points to flats
- External perimeter non-gated therefore courtyard opens to all.
- Bizarrely it is secured from tenants unless they have a key, or go around the side-entrance
- Problems with prostitution and drug-taking in court yard
- Looking to get gate fitted on the Phoenix Road entrance
- Unloved and under-utilized play area/football pitch and allotment (intended use for all residents of Eversholt Estate)
- Allotments are secured but interest in using them waned as residents didn't know enough about gardening to make use

## Unrepresented or un-contacted estates/streets

### **Charrington Street, Platt Street, Goldington Street (west), Penryn Street**

- Mainly Georgian townhouses comprising a mixture of privately owned and rented accommodation

- Not known to be represented by tenants association
- Residents largely un-contacted so exact mix of housing unknown
- Survived bombing during the war unlike many areas which have since been developed as social housing elsewhere in Somers Town.

### **Medway Estates**

- Mainly council housing
- Not known to be represented by tenants association

### **Sussex House, Chalton Street**

- Residents so-far uncontacted but is assumed to be privately owned or rented housing
- Not known to be represented by tenants association

### **Bridgeway House Estate**

- Camden Council housing
- Not known to be represented by tenants association

### **Jubilee Pub (converted into flats)**

- Not known to be represented by tenants association

## **Spaces and amenities**

### **Polygon Road (opposite Edith Neville school)**

- Open space used as a playground/open air gym for children
- Good example of a well-used and utilized space with many children using the playground for recreational leisure

### **South Camden Community School, Charrington Street**

- Tendency for school children to congregate outside school grounds outside of normal school hours and engage in anti-social behaviour(ASB) towards local residents
- Banging on residents windows, smoking or spitting near home entrance, threatening verbal behaviour cited as examples of anti-social behaviour.
- Police have been called out on a number of occasions.
- Sense of a defragmented community unable or unwilling to intervene to prevent ASB contrasting historically with a more hands-on approach by residents to mitigate ASB

### **Aloysius Roman Catholic Primary School**

- Good use of roof space with kids playground on top

### **Platt Street/Goldington Street**

- Godwin and Crowndale Community Hall- used?

**The Alfred Public House, Chalton Street**

- CLOSED and unused

**The Neptune Public House, Werrington Street**

- CLOSED and unused

**Oakley Square**

- Suspected use as an area for anti-social drinking and drug-taking.

**Police Depot Development Site, Doric Way**

- Quite a number of flats overlook the site (mainly Origin?)
- Concern from local residents about health impacts when redevelopment begins
- Would they consider sound and dust-proofing as is the case with some City of London developments?
- Brilliant opportunity for residents to use the neighbourhood planning process to prioritise what they want out of the redevelopment.
